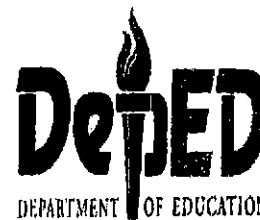

CORRIGENDUM TO DEPED MEMORANDUM NO. 282, S. 2004
(2nd National Children's Competition on Dramatic Folk Expression)

To: Regional Directors
Schools Division/City Superintendents
Heads, Public Elementary Schools

1. With reference to DepED Memorandum No. 282, s. 2004, Paragraphs 3, 4, 6 and 8 should be corrected to read as follows:

"3. The training component will be held on the following dates and venues:

Regions	Venue	Date
X, XI, XII, XIII and ARMM	Mindanao-Davao City, RELC	October 9-11, 2004
VI, VII, VIII and IX	Visayas-Cebu City, RELC	October 13-15, 2004
I, II, III, IV-A, IV-B, V, NCR and CAR	Luzon-Manila or UP, Quezon City	October 25-27, 2004

The trainor/director, music director, production designer, script writer and choreographer of the regional winner, one (1) division supervisor handling culture and arts and one (1) Regional Coordinator handling culture shall join the training program/sessions.

To enable the above mentioned division personnel to join the training, the Regional Coordinator is requested to conduct the inter-division competition prior to the training schedule.

The storylines of division contestants should be submitted to the International Organization of Folk Art (IOFA) on or before September 15. Regional winners should be known by September 30.

4. The competition is open to all public elementary schools in the country. Expenses may be charged against local school board funds or any available sources subject to the usual accounting and auditing rules and regulations.

6. There will be three (3) grand winners:

First prize	-	PhP100,000.00
Second prize	-	PhP 75,000.00
Third prize	-	PhP 50,000.00

The consolation prize for each of the fourteen (14) non-winners shall be PhP25,000.00 and a trophy. IOFA shall provide in-land transportation and shoulder the board and lodging of the seventeen (17) official delegates of each region from the time they arrive in Manila up to one (1) day after the contest.
