SUMMER CAMP BY THE SEA
(Paligsahan, Pasiklaban ng CELEX)



1. Pursuant to House Bill No. 13678, "An Act Providing for the Protection and Preservation of Philippine Cultural Heritage" and Presidential Proclamation No. 439, Declaring May of Every Year as National Heritage Month", the Center for Cultural Education (CCE) of the Department of Education (DepEd) in coordination with the National Commission for Culture and the Arts (NCCA), the Offices of the Governor of Pangasinan and the Mayor of San Fabian, Pangasinan announces the holding of "Summer Camp By The Sea" (Paligsahan, Pasiklaban ng CELEX on May 15-21, 2005 at the Mabilao Beach, San Fabian, Pangasinan.
2. The summer camp aims to:
 - a. heighten appreciation of heritage through lecture – demonstrations of cultural education lesson exemplars integrating nature and indigenous activities;
 - b. orient Makabayan teachers on the Cultural Education Concept Process Model and the Cultural Education Lesson Exemplars (CELEX); and
 - c. enhance teaching repertoire of Makabayan teachers through community and site-based experiences.
3. The seminar-workshop consists of lecturesses, demonstrations and games. Of the latter, the following are featured:
 - Dancing with the waves (sea rafting, pyramid building, swimming)
 - Soaring with the wind (kite flying, banner designs, sand castle building, sand painting, beach volley ball)
 - Playing seagods and seagoddesses (tuglarawan at dulayaw)
4. The participants shall be Makabayan teachers and coordinators. Teachers of CELEX Pilot Schools will be priority for the first one hundred slots.
5. Participants are requested to bring their own beddings.
6. A registration fee of Three Thousand pesos (PhP3,000.00) covering food (three meals and two snacks), lodging and handouts shall be charged each participant and shall be drawn from the local school board funds subject to its availability and the usual accounting and auditing rules and regulations. Travel allowances of participants shall also be charged to local funds.

7. Expenses related to the conduct of the workshop such as travel allowances, board and lodging of the resource persons and support staff shall be charged to the Office of the Secretary (OSEC). Honoraria of resource speakers, facilitators and support staff as well as prizes for the competition shall be externally sourced and charged to grants or sponsorships. All of these expenses are subject to their availability and the usual accounting and auditing rules and regulations.
