**2011 NAMCYA BALLET WORKSHOP**

1. The National Music Competitions for Young Artists (NAMCYA) Foundation, Inc., in cooperation with the Department of Education (DepEd), National Commission for Culture and the Arts (NCCA), Cultural Center of the Philippines (CCP), announces the holding of the **Ballet Workshops** on February 16-18, 2011 in Cagayan De Oro City, Region X and February 21-23, 2011 in Iloilo City, Region V.
2. The NAMCYA Ballet Workshops are part of the 2010 NAMCYA Continuing Program in support of the Competition. This activity aims to upgrade the skills of ballet/dance instructors and trainers, and equip them with efficient methods and techniques in Dance Education.
3. The participants to this master class are dance instructors/trainors from the Special Program for the Arts (SPA) schools and non-SPA private and public schools. Participants from public schools may attend **on official business**, while the participants from private institutions shall make arrangements with their respective schools with regards to their participation and expenses.
4. This is a live-out workshop and is limited only to thirty (30) participants. Since there is no registration fee for this workshop, travel, board and lodging, and other incidental expenses of the participants from public schools shall be charged against local funds, regional/division/school, PTA, School Board Funds and other sources and grants subject to its availability and the usual accounting and auditing rules and regulations. While travel expenses of the DepEd Culture and the Arts Office (CAO) staff shall be charged to OSEC funds subject to the usual accounting and auditing rules and regulations.
5. The Regional Directors of DepEd Regions VI and X, assisted by their regional and division supervisors and coordinators, are hereby requested to extend support and assistance in the conduct of this activity. All other DepEd regions may also send participants to this activity.




6. The NAMCYA Secretariat shall be the over-all in-charge in the conduct of these workshops. The DepEd CAO being the National Coordinator shall serve as support personnel for the Secretariat. They shall be allowed to attend, monitor and oversee the DepEd's participation in these Ballet Workshops.
