**AMENDMENT TO DEPED ORDER NO. 58, S. 2009**

(Designating a Focal Office to Handle Concerns and Activities Relative to Parents-Teachers Associations (PTAs) and its Federations)

1. DepEd Order No. 58, s. 2009 reads, among other things, as follows:

*1. Pursuant to DepEd Order No. 54, s. 2009 on the Revised Guidelines Governing Parents-Teachers Associations at the School Level, the Office of the Undersecretary for Regional Operations, thru the Center for Students and Co-Curricular Affairs (CSCA), is hereby designated as the focal office to handle concerns and activities of the Parents-Teachers Associations (PTAs) and its Federations.*

3. Therefore, the abovesited DepEd Order is hereby amended and shall read as follows:

**1. Pursuant to DepEd Order No. 54, s. 2009 on the Revised Guidelines Governing Parents-Teachers Associations at the School Level, the Office of the Undersecretary for Regional Operations, or its duly assigned office, is hereby designated as the focal office to handle concerns and activities of the Parents-Teachers Associations (PTAs) and its Federations.**

5. The Office of the Center for Students and Co-Curricular Affairs is hereby directed to turn over the handling of the concerns and activities of the PTAs and its federations to the Office of the Undersecretary for Regional Operations.
