**55TH ANNUAL NATIONAL COUNCIL MEETING (ANCM)
OF THE BOY SCOUTS OF THE PHILIPPINES (BSP)**

3. The participants to the ANCM are the BSP National Executive Board Members, DepEd Officials involved in Scouting, Council Chairmen, Local Council Scout Executives and other Local Council Officials representing the 113 Local Councils and the ten (10) Scouting Regions of the BSP.

4. The participants from the Department of Education (DepEd) are authorized to attend **on official business**. The registration fee, accommodation, transportation and other incidental expenses to be incurred by the participating DepEd officials and personnel shall be charged to local funds, subject to its availability and the usual accounting and auditing rules and regulations.
