2012 NAMCYA CHORAL WORKSHOP

To: Bureau Directors

1. The National Music Competitions for Young Artist (NAMCYA) Foundation, Inc. in cooperation with the Department of Education (DepEd), National Commission for Culture and the Arts (NCCA) and Cultural Center of the Philippines (CCP), announces the holding of the **2012 NAMCYA Choral Workshop** on February 27-29, 2012 at the RELC, Legazpi City, Albay.
2. The Choral Workshop is part of the 2012 NAMCYA Program in preparation for this year's competitions. It aims to upgrade the skills of choral instructors and trainers, and equip them with efficient methods and techniques in choral education, management and direction.
3. Participants shall include the music instructors from Special Program for the Arts (SPA) and music teachers from both public and private schools. Participants from the public schools may attend **on official business**. Participants from private institutions shall make arrangements with their respective school administrators.
4. The 2012 NAMCYA Choral Workshop is free of charge. However, travel and related expenses to be incurred by the teachers and participants shall be charged to local school/division/regional/Special Education Funds (SEF) and other sources of funds and grants subject to the availability and the usual accounting and auditing rules and regulations.
5. Regional directors (RDs) assisted by their regional and division supervisors and coordinators are hereby designated to oversee the selection and registration of participants in their respective areas.
6. The DepEd Culture and the Arts Office (CAO) will serve as the National Secretariat/Coordinator. Designated officers shall attend, monitor, and oversee the DepEd's participation in the choral workshop.
7. Travel expenses to be incurred by the members of the DepEd National Secretariat shall be charged to OSEC funds subject to its availability and the usual accounting and auditing rules and regulations.
