CHANGES IN THE COMPUTATION OF PUBLIC SCHOOL TEACHERS' PROPORTIONAL VACATION PAY (PVP) FOR SCHOOL YEAR (SY) 2013-2014

To: Regional Directors
 Schools Division Superintendents
 Heads, Public Elementary and Secondary Schools

1. The uniform basis for the computation of the Proportional Vacation Pay (PVP) entitled to all public elementary and secondary school teachers under the teacher's leave basis was provided in DepEd Memorandum No. 61, s. 2014. However, some changes have been made in the computation to read as follows:


- a. For School Year (SY) 2013-2014, teachers who have continuous services from June 3, 2013 to March 31, 2014 shall be entitled to **78 days total of PVP** (instead of 77 days) from Summer and Christmas vacation days, which is computed as follows:

Total Number of days served	=	302 days
from June 3, 2013 to March 31, 2014		
Less: Number of Christmas vacation days earned	=	<u>-16 days</u>
from December 21, 2013 to January 5, 2014		
Actual days served	=	286 days
Multiply factor (instead of 0.269)	=	<u>x 0.273</u>
Total PVP earned from the number of Summer and Christmas vacation days	=	78 days
Less: Number of Christmas vacation days	=	<u>-16 days</u>
Number of the Summer vacation days earned from April 1 to June 1, 2014 (instead of 61 days)	=	62 days

- b. Factor **0.273** shall be used for the computation of absences and PVP for SY 2013-2014. Below is the **derivation of factor 0.273**.

Number of Summer vacation days	=	62 days
Add: Number of Christmas vacation days	=	<u>+16 days</u>
Total PVP (Summer and Christmas vacation days)	=	78 days
Divided by actual days served	=	286 days
Multiply factor	=	0.273
