This Bid Bulletin is hereby issued for the information and guidance of all prospective bidders. It shall form an integral part of the bidding documents issued earlier relative to above project.

I. Section I. Invitation to Bid, p. 5; and Section III. Bid Data Sheet, ITB Clause 21 and 24.1, p. 49-50 is hereby amended to read as follows:

The deadline for submission of bids is on <u>August 17</u>, <u>2018</u>, 9:00 A.M.

The place of bid opening is at <u>ProcS Conference Room</u>, <u>Rm. 419</u>, <u>4/F</u>, <u>Mabini Bldg.</u>, <u>DepEd Complex</u>, <u>Meralco Ave.</u>, <u>Pasig City</u>.

The date and time of bid opening is on <u>August 17, 2018</u>, <u>9:00 A.M.</u>

II. Section III. Bid Data Sheet, ITB Clause 12.1, page 39, is hereby amended to read as follows:

Documents Comprising the Bid: Eligibility and Technical Components

Pursuant to GPPB Circular 07-2017 dated July 7, 2017, bidders may still submit their Class "A" Eligibility Documents required to be uploaded and maintained current and updated in the PhilGEPS pursuant to Section 8.5.2 of the same IRR, or if already registered in the PhilGEPS under Platinum category, their Certificate of Registration and Membership in lieu of their uploaded file of Class "A" Documents, or a combination



thereof. In case the bidder opted to submit their Class "A" Documents, the Certificate of PhilGEPS Registration (Platinum Membership) shall remain as a post-qualification requirement to be submitted in accordance with Section 34.2 of the 2016 Revised IRR of RA 9184.

The original or authentic copy of the Class "A" documents shall be required during post-qualification. The valid and current Mayor's permit/municipal license, shall be supported by the appropriate Official Receipt (O.R.) of payment for the current quarter/year if required by the municipality, as indicated in the permit submitted.

Foreign firms that will participate as foreign bidders or in joint venture with Filipino-owned firms shall submit the required Class "A" documents and other supporting documents or printed literature, in accurate translation in English. Each of these documents shall be individually certified by the appropriate embassy or consulate in the Philippines to ensure that each of the documents is verified and authenticated. Said documents shall be verified and authenticated by Office of Consular Affairs, Department of Foreign Affairs (DFA), Manila. Philippines. Hence, a Certificate of Authenticity issued by DFA shall be submitted together with the other technical component requirements.

 - CCTV equipment, accessories and peripherals: Shall provide warranty for all the components including hardware, software, etc. for a period of three (3) Years from the date of the issuance of Final Acceptance Certificate. All CCTV equipment, accessories and peripherals shall be approved by the End-User prior to installation.

- VI. Section VI. Specification, VI. Other Equipment B. Audio-Video System pages 104, 114, 125, 136, 147, the following is hereby amended to read as follows:
 - Audio-video system equipment, accessories and peripherals: Shall provide warranty for all the components including hardware, software, etc. for a period of three (3) Years from the date of the issuance of Final Acceptance Certificate. Complete audio-video system equipment along with necessary accessories and peripherals shall be approved by the End-User prior to installation.
