**CONVENTION OF THE INTEGRATED PROFESSIONAL

The Integrated Professional Counselors Association of the Philippines (IPCAP), Inc. will hold its **Convention** on September 16-18, 2010 with the theme, *“Empowering Counselors to Reach-Out to Families”* at the Asian Seminary of Christian Ministries, 102 Valero St., Salcedo Village, Makati City.

The objectives of the convention are to:
