PAGLIPAD NG ANGEL
(Flight of an Angel)

The Spears Activation and PR Company announces the film viewing of the award winning movie entitled *Paglipad ng Angel (Flight of an Angel)*.

The movie won the award for Best Fiction Feature in the Spirituality section of the 12th Dhaka International Film Festival 2012, starring actor Mr. Sid Lucero, LJ Moreno, and Christian Vasquez, directed by Dr Clodualdo del Mundo, Jr. This movie was the Filipino film entry during the Cine Europa Film Festival 15 (European Film Fest 2012) held in Shangri-La, participated by 29 countries including the Philippines and the members of European Union. Also, this film was featured during the Cinemalaya 2011 and nominated for the Best Motion Picture-Drama during the 9th Golden Screen Awards 2011.

The *Paglipad ng Angel (Flight of an Angel)* is a gentle film, very much in the Filipino cultural style, a mixture of fantasy and humour, with an underlying moral perspective. The jury described the film thus, a good-living young man performs a kindness and finds he grows wings and becomes an angel. This challenges his way of seeing himself as an ordinary man, strengths and flaws. It is the tradition of many popular films, especially American, like *It's a Wonderful Life*, which see angels as symbols of transcendence and grace.
