CRYSTAL JUBILEE ASSEMBLY OF THE FEDERATION OF ASSOCIATION  
OF PRIVATE SCHOOLS AND ADMINISTRATORS (FAPSA)

The Federation of Association of Private Schools and Administrators (FAPSA) will hold its *Crystal Jubilee Assembly* with the theme *FAPSA Braving Its Financial Predicament in Private Schools' Operation* on November 25, 2013 at the Manila Ocean Park, Luneta Park, Manila.

The Assembly aims to thresh out the following:

1. Financial aid of the government to students in private schools which is spelled out in the implementing rules and regulations (IRR) of Republic Act No. 10533 otherwise known as the Enhanced Basic Education Act of 2013 (K to 12 Basic Education Program);
2. FAPSA as possible DepEd contractual partner in implementing the Senior High School (SHS) Program under the K to 12 Program;
3. Private schools as partakers in 50% of 1% in Special Education Fund (SEF) from government internal revenue allotment;
4. Creation of the private school bureau for assistance to schools but not for added regulations;
5. Threshing out of double SHS competitors: the public schools and the tertiary schools; and
6. Recognition and giving of awards to FAPSA Education Partners from the Tri-Media.

The target participants to this activity are administrators from private schools and officers of private school associations nationwide.

Participation of both public and private schools shall be subject to the *no-disruption-of-classes policy* as stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
