### CINE CARAVAN

The MEDIAKOM, a trademark of Melcor Enterprises, announces its mobile cinema project dubbed as *Cine Caravan*. This will showcase the hip hop dance-musical film entitled *Kaleidoscope World*, which was the eighth official entry to the Metro Manila Film Festival.

The Cine Caravan aims to:

1. bring Filipino Independent films to the doorsteps of the various communities to build a new market and create a thriving festival circuit; and
2. showcase said film which is an opportunity for education enhancement; a tool for re-engineering local mindsets; an income-generating activity for local units; and a quality and affordable entertainment media.

A *Kaleidoscope World*, is a love story between a poor boy and rich girl who both have a love of hip hop dance. Their story is woven together by hip hop dances inspired by the music of the late Francis Magalona songs. A new light is shed on hip hop dancers showcasing the inherent talent among homegrown talents which make them world class dance champions.

The target audience are the youth (adolescent up to 30 years old), the hip hop community (dancers, flip top artists, graffiti artists, DJs, rap-song artists), among others from both public and private elementary and secondary schools.

This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546, *An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law)*.
