## 2015 MATHEMATICS TRAINERS' GUILD (MTG) QUALIFYING EXAMINATION AND TRAINING PROGRAMS

The Mathematics Trainers' Guild (MTG) Philippines will conduct its *2015 Qualifying Examination and Training Programs* on July 11, 2015 in the different MTG training centers in the Philippines.

The Qualifying Examination and Training Programs aim to:

1. seek to evaluate the breadth of the students' mathematical knowledge and skills;
2. select superior students in the field of Mathematics for further training and advancement;
3. provide the Filipino youths the appropriate venue to enhance their Mathematic skills through phases of training; and
4. develop mathematical potentials of the promising Mathematics students to meet the international math standards.

The Philippine Board of Studies Foundation (PBOSF) Inc. will sponsor the registration fees of students in the public schools, thus registration is *Free of Charge* to all interested public elementary pupils and secondary students.

The target participants are pupils and students from both public and private elementary and secondary schools.

The students who will pass the Qualifying Examination shall be eligible to enrol and pursue the following MTG training programs:

1. *Mathematical Challenge for Filipino Kids Training Program (MCFKTP)* – has a total of 12 Saturday sessions which are usually conducted for three hours within the academic year;
2. *Young Mathematical In-house Intensive Training Program (YMIITP)* – is a four-day in-house intensive training program where the MCFKTP top scorers are invited to attend and are given lectures and battery of quizzes and examinations to select the qualifying and alternates; and
3. *Mathematical Olympiad Summer Training Program (MOSTP)* – is a month-long training of YMIITP qualifiers and alternates who will be equipped with advance math contents, concepts and strategies in preparation for their participation in different international math contests abroad.

Participation of both public and private schools shall be subject to the *no-disruption-of-classes policy* stipulated in DepEd Order No. 9, s. 2005 entitled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith*.
