NATIONAL TRAINING OF TRAINORS IN ARNIS AND DANCE SPORT

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents

- 1. Arnis and Dance Sport are two of the priority sports where Filipinos can excel, as shown in the last SEA GAMES, where the Philippine Team garnered Gold medals. It is therefore, in order, that these sports are included in the Palarong Pambansa program of the DepED.
- 2. As demonstration sports in the 2006 Palarong Pambansa, the Department of Education, through the Task Force on School Sports (TFSS), in cooperation with Arnis Philippines and the Professional Dance Sport Association, shall conduct the **National Training of Trainors in Arnis and Dance Sport.** The training in arnis shall be held on March 13-17, 2006, while the training in dance sport shall be held on March 13-14, 2006, both at Teachers Camp, Baguio City. During the period, there shall be a consultative meeting of the Heads of Regional Task Force on School Sports, on matters pertaining to the conduct of regional meets, the Palarong Pambansa, and other related activities.
- 3. The training aims to orient trainors on the fundamentals and rules of arnis and dance sport, and train them on the mechanics of officiating in said sports. Participants are expected to conduct echo seminars in their respective localities.
- 4. Participants to the training shall be the Heads of Regional TFSS/PESS Chiefs or their representatives, Division PESS Supervisors (for arnis), and 5 pairs of supervisors/PESS coordinators (for dance sport from each region), who have the knowledge and skills in said sports.
- 5. A registration fee of Four Thousand Eight Hundred Pesos (PhP4,800.00) shall be charged each participant in arnis, while participants in dance sport shall be charged Three Thousand Pesos (PhP3,000.00) to cover board and lodging, training kit, manual/materials, extra duty allowance, and other related expenses. Registration fee, transportation, per diem and other incidental expenses to be incurred by the participants shall be charged against local funds.
- 6. Board and lodging of management staff, resource persons, and Regional TFSS Heads/PESS Chiefs or their representatives, transportation, per diem of management staff and resource persons, and other incidental expenses to be incurred during the training shall be charged against A.II.d.1 funds subject to the usual accounting and auditing rules and regulations.
