**THE PALARONG PAMBANSA BOARD**

1. In accordance with Executive Order No. 433, transferring the management of the Palarong Pambansa from the Philippine Sports Commission (PSC) to the Department of Education, the Palarong Pambansa Board is hereby organized, as follows:



The Palarong Pambansa Board shall formulate policies and guidelines that shall govern the conduct of the Palarong Pambansa and other related school sports activities, approve budget allocations for the Palaro, decide on the host of the Palaro, and to directly supervise the preparation and conduct of the Palaro.

2. The DepED Regional Offices shall organize their Regional Athletic Associations (RAAs) using the same organizational pattern, including the local government units (LGUs) in their regions. The RAAs shall supervise the division meets in their respective regions, conduct their regional athletic meets, and organize the regional delegation for the Palarong Pambansa.

3. The Host Palaro Executive Committee shall be organized and it shall be in charge of the hosting of the Palaro. It will be composed of the Head of the host LGU as the Chairman, the DepEd Regional Director as Co-Chairman and the host Schools Division Superintendent as the Executive Secretary. Members shall be the Chairmen of the Working Committees who will be designated by the Chairman of the Executive Committee.

Immediate and wide dissemination of this memorandum is desired.
