SUBJECT: **National Workshop on the Finalization of the Country EFA Mid-Decade Assessment Report (2000-2005)**

1. With reference to DepED Order No. 27, s. 2006 on the implementation of the Philippine Education For All (EFA) 2015 Plan's Critical Task on Regular Monitoring of Progress of basic education, the series of Trainings cum Writeshops on Sector M&E and Strategic Planning participated in by the EFA Planning and M&E Teams from the regions and division offices have been completed.

2. As part of the agreements made with the participants, the Regional EFA MDA Reports initially prepared during the abovementioned activities will be further refined/fine-tuned by the Regional and Divisional EFA Planning and M&E Teams. Once finalized, the report shall be submitted to DepED-Central Office for integration. The Office of Planning Service is tasked to consolidate the regional reports and to come-up with a Draft Country MDA Report which will be submitted to UNESCO in December 2006.

3. In view of this, a **National Workshop** to validate/fine – tune the Draft Country EFA MDA Report will be conducted on October 24-26, 2006 in a venue to be announced later. Participants are selected representatives from the Central Office; the Regional EFA Planning and M & E teams; members of EFA National Education Committee; and Presidents/representatives of different DepED associations. Enclosure Nos. 1 and 2 shows the Indicative Programme of Activities and List of Participants.

All expenses such as board and lodging and travel costs of participants will be charged to OPS-TEEP Project Fund through reimbursement scheme during the actual activity subject to the usual accounting and auditing rules and regulations.

4.
