ORIENTATION SEMINAR ON CAREER GUIDANCE ORGANIZED BY DEPED, CHED and TESDA

To: Regional Directors

Schools Division/City Superintendents

- 1. The Technical Working Group on Unified Assessment composed of select officials and staff from the Department of Education (DepED), Commission on Higher Education (CHED) and Technical Education Skills Development Authority (TESDA) shall conduct An Orientation Seminar on Career Guidance based on the results of the National Career Assessment Examination (NCAE).
- The following shall be discussed in said activity:
 - Using the NCAE Results for Career Guidance
 - Employment Opportunities in the Key Employment Generators
 - Higher Education Institutions Offering Quality Programs in the Priority and Highly Marketable Disciplines
 - TESDA Programs for Priority Skills
 - Student Scholarship Grants for Priority Disciplines/Program
 - Career Guidance Framework
 - Synthesizing Information for Career Counseling
- 3. Authorized to attend/participate are the following:
 - a. DepED Guidance Supervisors one (1) per Division
 - b. CHED Guidance Counselors
 - c. TESDA Guidance Coordinator
- 4. The participants shall be divided into five (4) clusters, namely, Northern Luzon Divisions; Southern Luzon Divisions including National Capital Region (NCR); Visayas composed of Regions VI, VII, VIII and Schools Divisions of Isabela City, Sulu I, Sulu II, Basilan, Tawi-Tawi and Zamboanga City; and Mindanao composed of Regions IX, X, XI, XII, CARAGA and Schools Divisions of Maguindanao, Lanao del Sur I, Lanao del Sur II and Marawi City.

5. The live-out workshop shall be conducted for two (2) days per cluster on the following dates and venues:

Cluster	Dates	Venue
Northern Luzon	February 26-27, 2007	Quezon City
Southern Luzon and NCR	February 28-March 1, 2007	Quezon City
Visayas	March 5-6, 2007	Cebu City
Mindanao	March 8-9, 2007	Davao City

- 6. The specific venues per cluster shall be announced at a later date.
- 7. Transportation and per diems shall be charged to local funds subject to the usual accounting and auditing rules and regulations.
- 8. Immediate and wide dissemination of this Memorandum is desired.
