**DESIGNATING KEY OFFICIALS FOR THE  
MANAGEMENT OF THE PALARONG PAMBANSA**

To: Undersecretaries  
Assistant Secretaries

Heads of Public and Private Schools

1. The Palarong Pambansa Board, as per DepED Memorandum No. 229 s. 2006 and DepED Memorandum No. 65 s. 2007, shall be the governing body for the Palarong Pambansa.

2. Undersecretary Ramon C. Bacani is hereby designated as Secretary-General of the Technical Management and Games Administration (TMGA) of the Palarong Pambansa. The Task Force on School Sports (TFSS) shall provide the secretariat, operational works and staff assistance for the Secretary-General, with the TFSS National Coordinator designated as the Deputy Secretary-General and Chairman of the Technical Committee.

3. Undersecretary Teodosio C. Sangil, Jr. shall be the Chairman of the Executive Committee (EC) with Undersecretaries Ramon C. Bacani, Franklin C. Suñga and Vilma L. Labrador as Co-Vice Chairmen.


Director Rolando C. Brillantes and Mr. Cesar Abalon shall oversee, on behalf of the Chairman of the Executive Committee, the process of screening and accreditation of athletes, coaches and chaperons to ensure that the principles of honesty and fair competition are adhered to and that any anomaly is prevented. They shall assist the Executive Committee in resolving any eligibility issues that may be elevated to the Committee.

4. The TFSS shall serve as the Secretariat of the Palarong Pambansa and its staff complement shall be augmented as necessary. It shall also provide secretariat services to the Palarong Pambansa Board and the Executive Committee.

5. The Palarong Pambansa Program shall be implemented in accordance with the existing administrative and operational policies of the Department of Education and in conformity with the principles and guidelines of the National Unified Sports Program.

6. This DepED Memorandum supersedes Office Memorandum dated March 2, 2007, designating the Palarong Pambansa Secretary-General and Chairman of the Technical Committee. Pertinent provisions of DepED Memorandum No. 87 s. 2007 with respect to the Palarong Pambansa Board, Secretary-General, Executive Committee and the Palarong Pambansa Secretariat are hereby amended accordingly.

7. Immediate and wide dissemination of this memorandum is desired.
