1. The 2007 DepED Election Task Force (ETF) Operation Center will be established in the Bulwagan ng Karunungan, Department of Education Central Office, Meralco Avenue, Pasig City on May 12-16, 2007.
2. The DepED Election Task Force (ETF) will ensure that teachers shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties as members of Board of Election Inspectors (BEI).
3. The DepED ETF Operation Center shall also serve as DepED's institutional link to volunteer organizations, individuals as well as partner agencies involved in the May 14, 2007 elections.
4. As members of the steering group, Undersecretary Teodosio C. Sangil, Jr. shall be in charge of monitoring and handling various election concerns in Region IV-B (MIMAROPA), while Undersecretary Manaros B. Boransing will be in charge of monitoring and handling various election concerns in the Mindanao area except Lanao del Sur and Undersecretary Antonio A. Inocentes will be in charge of monitoring and handling various election concerns in Region II and Region VI.
5. The list of management and administrative/operational staff relative to the preparation and actual operation of the DepED ETF providing its composition is hereto enclosed.
