EDUCATION FOR ALL THRU RADIO (EFAR) NATIONAL
TRAINING OF TRAINERS (NTOT)

1. The Education for All thru Radio (EFAR) project aims to build a network of content providers, broadcasters, teaching institutions, technology providers, and development organizations that will actively promote and harness radio as an effective and sustainable means of providing education services particularly to those segments of the population who have special needs and with little or no access to such services through traditional means.
2. The project is funded by the Coca-Cola Company and implemented by the Foundation Information Technology Education and Development (FIT-ED) in partnership with DepED, together with UP National Institute for Science and Mathematics Education and Development (NISMED) and the Alternative Forum for Research in Mindanao (AFRIM).
