NATIONAL FEDERATION OF SUPREME STUDENT GOVERNMENTS CONFERENCE

- 1. The Department of Education-Center for Students and Co-Curricular Affairs (CSCA) will conduct the National Federation of Supreme Student Governments (NFSSG) Conference on February 4-8, 2008 in Cagayan de Oro City.
- 2. This annual conference aims to achieve the following objectives:
 - a. Evaluate the implementation of the Student Government Program (SGP) and the Constitution and By-Laws of the Supreme Student Governments, including the conduct of the 5th National Leadership Training for Student Government Officers (NLTSGO);
 - b. Identify issues and concerns pertinent to the SGP implementation and the conduct of the 5th NLTSGO and recommend measures to address such issues and concerns;
 - c. Evaluate the midterm implementation of the Thrusts and Activities of the SGP for School Year 2007-2008;
 - d. Discuss programs, projects and ways in harnessing the student government as an effective partner in achieving quality education and academic excellence in schools; and,
 - e. Improve efforts in making available real exposure, experience and learning in responsible and participative democracy and leadership.
- 3. Participants to this evaluation and planning conference (list enclosed) are the Officers of the National Federation of Supreme Student Governments (NFSSG), Araling Panlipunan Regional Supervisors or the Student Government Program Regional Coordinators and DepED-CSCA personnel. Participants are expected to be at the venue in time for dinner of February 4, 2008 until lunch of February 8, 2008 which shall be shouldered by the DepED-CSCA.
- 4. Travel expenses and other incidental expenses of participants, except the officers of the National Federation of Supreme Student Governments, shall be charged against local funds. Expenses for board and lodging, supplies and materials shall be shouldered by the DepEd-CSCA chargeable against the excess funds generated from the conduct of the 5th NLTSGO. Transportation expenses of the NFSSG Officers, CSCA Staff and Resource Persons shall be charged against DepED Central Office funds.
