27<sup>TH</sup> ANNUAL CONVENTION OF THE PRIVATE SCHOOL HEALTH OFFICERS  
ASSOCIATION (PSHOA), INC. AND ELECTION  
OF NEW BOARD OF DIRECTORS

1. The Private School Health Officers' Association (PSHOA), Inc. will hold its 27<sup>th</sup> Annual Convention and Election of New Board of Directors on April 3-4, 2008 at the Bayanihan Hall, United Laboratories, Inc., Mandaluyong City with the theme "PSHOA, as it Reflects on Behavioral Lapses and Environmental Maladies (P.R.O.B.L.E.M.)".
2. The objectives of the convention are to:
  - a. create, promote and instill awareness on the deviant child as seen in pre-school obesity and ADHD as well as in handling different dental treatment on a disabled youngster;
