1. In line with the provisions of DepED Order No. 72, s. 2007, the Legislative Liaison Unit, in collaboration with the Office of the Assistant Secretary for Special Projects and Legislative Liaison and the Office of the Undersecretary for Legal and Legislative Affairs, will conduct a Consultative Workshop on the Legislative Agenda of the Department of Education for the Fourteenth (14<sup>th</sup>) Congress, on March 5-8, 2008 at DAP Conference Center, Sungay East, Tagaytay City.
2. The workshop aims to:
  - a. inform the participants of the legislative process;
  - b. come up with effective and decisive legislative measures corollary to the Department's legislative agenda;
  - c. develop the Department's position on pending measures in Congress, and
  - d. finalize said legislative measures for submission and approval of the Secretary.

Participants to this workshop are the Top Management Officials, Bureau and Service Directors, Representative/s of the Regional Directors Association, Regional Legal Officers, Representative/s of the Public Elementary and Secondary Schools Principals Association and Public Schools District Supervisors' representative/s of Private Schools, DepED Union Officials and other stakeholders.

Board and lodging of participants, extra-duty allowance of organizers, speakers, facilitators and staff, hand-outs/materials and other incidental expenses are chargeable to OSEC funds, while traveling expenses of those coming from the regional and division offices shall be borne by their respective local funds, subject to the usual accounting and auditing rules and regulations.
