**SCHOLARSHIP PROGRAM FOR SPED TEACHERS ON HEARING
IMPAIRMENT AND CHILDREN WITH INTELLECTUAL DISABILITY**

To: Bureau Directors
Regional Directors
Schools Division/City Superintendents

1. In support to the thrust of improving quality education for children with special needs, the Bureau of Elementary Education, Special Education Division, (BEE-SPED) announces the conduct of the Training Programs for SPED Teachers on Hearing Impairment and Children with Intellectual Disability for Summer 2009 and the Semestral Break.
2. The scholarship program aims to provide the SPED teachers knowledge and skills on various educational programs and intervention appropriate for children with these special needs. This will be conducted in selected Centers of Excellence. This year's scholarship program shall be conducted in two phases. Phase I shall be held in Summer (April-May) and Phase II shall be done during the semestral break (October).
3. Priority nominees shall come from the identified regions/divisions/schools where there is an urgent need for these SPED teachers (See Enclosure No. 3). These nominees shall be screened by the existing Regional Integrated Scholarship Committee (RISC) based on the criteria set in Enclosure No. 1. Deadline for submission of nominees to the region is on March 31, 2009. The list of candidates together with the documents and the Memorandum of Agreement (Training Contact) duly signed by the proper authorities concerned (See Enclosure No. 2) shall be forwarded to the Special Education Division, Bureau of Elementary Education, DepED Complex, Meralco Avenue, Pasig City on or before April 6, 2009. Likewise, the list of returning participants for last year is found in Enclosure No. 4.
4. The SPED scholars are entitled to their salaries, course tuition fees and stipend of Eleven Thousand Pesos (PhP11,000.00) for the two phases of the scholarship. DepED shall provide their travel expenses only at the most economical mode of transportation and per diem for 2 days (1 day before and 1 day after) in going to and from the venue which will be paid on the last week of the course.

5. Incidental expenses including transportation and in planning of activities related to the implementation of the training shall be charged against the DepED Human Resource Training and Development (HRTD) funds subject to the usual accounting and auditing rules and regulations.

6. Immediate dissemination of this Memorandum is desired.

A. Guidelines for the Selection of New SPED Scholars

1. The Regional Integrated Scholarship Committee (RISC) shall screen and identify the new teacher-grantees to be considered in the program following a set of criteria.
2. The RISC submits the list of scholars to the Special Education Division, Bureau of Elementary Education on or before April 6, 2009. The names indicated in the list shall be final.
3. The following are the criteria for the selection of nominees for the training courses:
 - A bachelor's degree holder related to the area of scholarship with a grade point average of not lower than **2/ B / 85**.
 - Has been a teacher for at least three years under permanent status with a performance rating of at least Very Satisfactory (VS)
 - Not more than 45 years old
 - Has no pending administrative case and/or criminal record
 - Has been certified by a government physician to be physically, mentally fit and not pregnant during the scholarship period .
 - Has not availed of any scholarship/training program for at least two (2) years
 - Possesses leadership potential, facilitation skills, positive attitude to mentor or coach other teachers in his/her school / division as necessary
 - Can communicate effectively in English
 - Can develop and implement relevant re-entry plan
 - Must have prospective clientele for the organization of classes right after the training.
4. The documents / pertinent papers to be submitted by the nominees to their Regional Integrated Scholarship Committees are as follows:
 - CSC Form 212 (personal data sheet) with a 2"x2" recent photo duly certified by the administrative officer
 - Certified photocopy of the transcript of records
 - Form 86 (health certificate) from an accredited government hospital
 - Service record
 - Certification from the principal/immediate supervisor that the nominee is actually teaching the subject he/she is recommended for
 - Endorsement from the superintendent
 - Duly accomplished scholarship contract between the scholar and the schools division superintendent to guarantee the implementation of re-entry plan.
5. Selected scholars will be informed through the regional offices.

4. Submit to the Bureau of Elementary Education at the end of the training a copy of his/her action plan;
5. Immediately report to his/her station and assume his/her function upon the completion or termination of the training;
6. Organize SPED programs or classes for children with hearing impairment and children with intellectual disability (MR).
7. Shall serve his/her school/agency for at least (2) years after the training;
8. Shall refund in full to his/her school/agency and to the Department such sums of money as may have been defrayed by the Philippine Government if he/she fails to provide educational services to the children with special needs for two (2) years after the summer training and semestral break; and
9. Shall live up to the terms and conditions of this scholarship.
