CAPACITY BUILDING OF SCHOOLS IMPLEMENTING THE SPECIAL PROGRAM IN SPORTS (SPS)

To: Undersecretaries

- 1. The Bureau of Secondary Education (BSE) shall conduct a training of the Special Program in Sports (SPS) on May 16-20, 2009 at Teachers Camp, Baguio City.
- 2. The training aims to continuously enhance the knowledge and understanding on the administration of the program, upgrade the level of competence of those implementing the program in the lead schools and improve the level of student performance during sports competitions.
- 3. Participants to the training shall be one (1) Regional Sports Supervisor, one (1) Division Sports Coordinator where the pilot school is situated, School Heads and teachers of the seventeen (17) lead SPS schools that were allotted Five Hundred Thousand Pesos (PhP500,000.00) subsidy by the Department.
- 4. Schools that have been successfully implementing the program may join the training, provided they have a track record of high performance based on the results of the sports competitions they have competed in. Teachers from those schools that may want to participate must have the knowledge and skills in the following sports events: athletics, badminton, basketball, baseball, chess, football, gymnastics, sepak takraw, softball, swimming, table tennis, taekwondo, tennis and volleyball.
- 5. A registration fee of Five Thousand Pesos (PhP5,000.00) shall be charged each participant to cover board and lodging, rentals of sports facilities and equipment, training kit, transportation of participants to and from the practicum venue, honoraria of training staff and other incidental expenses relative to the training. Participants shall charge their registration fee and traveling expenses from the financial subsidy they received or from local funds, as the case may be. Traveling expenses, board and lodging and other incidental expenses of resource persons and BSE staff shall be charged against BSE funds. All expenses are subject to the usual accounting and auditing rules and regulations.

- 5. Registration shall start on May 15, 2009 at 1:30 pm at the Quezon Hall, Teachers Camp, Baguio City. First meal shall be dinner on May 15 and last meal shall be lunch on May 20, 2009.
