1. Pursuant to DepED Order No. 55, s. 2002 on the Revitalized Youth Entrepreneurship and Cooperativism in Schools (YECS) Program, the Department of Education-Center for Students and Co-Curricular Affairs (DepED-CSCA) will conduct the **Youth Entrepreneurship and Cooperativism in Schools (YECS) Annual Evaluation and Planning Conference and Workshop** from September 28 to October 2, 2009 in Cagayan de Oro City.
2. This annual conference aims to achieve the following objectives:

3. Participants to this evaluation and planning conference are the Regional TLE Supervisors in-Charge of the YECS Program, resource persons, facilitators, guests and the staff of the Department of Education-Center for Students and Co-Curricular Affairs.
4. Participants are expected to arrive before 12:00 nn on September 28, 2009 and to depart from the venue on October 2, 2009. The DepED-CSCA shall shoulder board and lodging beginning lunch on September 28, 2009 until breakfast on October 2, 2009 only. The DepED-CSCA staff are authorized to travel one (1) day before and one (1) day after the conference and workshop.
5. Travel and other incidental expenses of participants from DepED Regional Offices shall be charged against local funds. Expenses for food and accommodation, supplies and materials and other incidental and necessary expenses shall be charged against the excess funds generated by the DepED-CSCA from the conduct of its national events, while transportation of DepED Central Office personnel, resource persons, facilitators and guests, shall be charged against DepED-OSEC funds.
