2010 MONITORING AND EVALUATION OF 282 TECH-VOC HIGH SCHOOLS

1. One of the vital program components of the Strengthened Technical-Vocational Education Program (STVEP) implemented in the 282 tech-voc high schools is the Monitoring and Evaluation specified under DepED Order No. 48, s. 2007. To evaluate the efficiency and effectiveness of the program, a nationwide Monitoring and Evaluation of tech-voc high schools shall be conducted between January to March 2010.

2. The objectives of the monitoring and evaluation are to:

- a. determine the status of the release and utilization of funds for the tools and equipment and the competency assessment subsidy given to 282 tech-voc high schools;
- b. monitor the status of STVE curriculum implementation (in terms of best practices per specialization, teaching and learning strategies, competency assessment, utilization of instructional materials and others);
- c. track the progress of teachers and students development and others;
- d. find out the application of competencies acquired by the vocational school administrators/principals, head teachers, teachers and non-teaching staff in the various training programs attended;
- e. determine the actual allocation of teachers items intended for tech-voc high schools;
- f. determine the status on the utilization of the rehabilitation funds provided for the 142 tech-voc high schools;
- g. gather best practices and models of tech-voc education program implementation; and
- h. identify gaps, issues, concerns and challenges encountered during the implementation of the program and actions taken to address the problems.

3. A Monitoring Team shall be assigned per region. In this regard, all concerned regional, division and school officials are hereby directed to cooperate and assist the Monitoring Teams in their school visit as they will inspect schools, interview concerned persons and document their monitoring and evaluation activity. Enclosed is the list of Monitoring Teams and their corresponding schedule, for reference.



4. All expenses to be incurred by the regional, division and school officials shall be charged against local funds subject to its availability and the usual accounting and auditing rules and regulations.
