THIRD NASSPHIL NATIONAL ADMINISTRATORS CONGRESS

1. The National Association of Secondary Schools of the Philippines (NASSPHIL), Inc. in coordination with the Bureau of Secondary Education (BSE)) announces the holding of the **Third National Administrators Congress** to be held at Eco Village Station 2, Boracay Island, Malay, Aklan on April 7-9, 2010. The theme of the congress is *"Towards A Firmer Grasp of the Nuances of School Management (Turning Over a New Leaf, Welcoming a New Lead)"*.

2. The congress aims to:

- a. assess the immediate past performance of Philippine education in general and secondary education in particular in order to set concrete directions for secondary education in the current year and decade; and
- b. provide an opportunity for a better understanding of the tools needed to ensure school-based quality management and an exchange of notes of experience among school administrators in anticipation of possible strategic planning for their respective schools for the next five years.

3. The participants to this congress are the Public and Private Secondary School Principals, Assistant Principals, Secondary School Head Teachers/Department Heads, Officers and teacher members of the NASSPHIL Mother Board and heads of secondary trade-agriculture-fisheries, the Chiefs of Secondary Education Divisions, Supervisors in-charge of public and private schools and the Schools Division Superintendents and the Assistant Schools Division Superintendents in-charge of secondary schools. Attendance of the public school participants including the working committee members shall be **on official business**.

4. A registration fee of Five Thousand Pesos (PhP5,000.00) per participant, including working committee members shall be charged to cover board and lodging, materials and other related congress expenses. Members of the different committees, as well as the present NASSPHIL officers and board of directors are authorized to travel two (2) days before the congress. First meal starts with p.m. snacks on April 7 and last meal shall be lunch on April 9, 2010. Traveling expenses and registration fee shall be charged against local funds, subject to its availability and the usual accounting and auditing rules and regulations.
