

2010 SEAMEO INNOTECH PROGRAM ON DEPED INSTRUCTIONAL AND CURRICULAR EXCELLENCE IN SCHOOL LEADERSHIP AND MANAGEMENT FOR SOUTHEAST ASIA (DepEd eXCELS III)

- 1. The Department of Education (DepEd) through the Southeast Asian Ministers of Education Organization Regional Center for Educational Innovation and Technology (SEAMEO INNOTECH) will conduct the 2010 Scholarship Program on DepEd Instructional and Curricular Excellence in School Leadership and Management for Southeast Asia (DepEd eXCELS III) for Elementary and Secondary School Principals, Assistant Principals, Head Teachers, Teachers-in-Charge and others performing management functions in the schools.
- 2. This foundation eXCELS course or training program addresses the requirement of the Department for building management capability at the school level to build and enhance competencies that would enable them to effectively fulfill their current and emerging roles and functions as instructional leaders.
- 3. Participants to this program are Elementary and Secondary School Principals, Assistant Principals, Head Teachers, Teachers-in-Charge and others performing management functions in the schools who are 60 years old and below and can access a computer with internet connection in the school or a nearby internet café or similar facility. Those who have participated in previous AIM/DepEd eXCELS I and II/PHRDF training programs are not eligible to attend this particular program. Enclosed is a DepEd eXCELS Self-Assessment Form that will guide the selection of qualified participants.
- 4. The DepEd eXCELS Scholarship Program for CY 2010 is a one-month capability-building program for elementary and secondary school heads and/or school principals conducted through IFLEX or INNOTECH Flexible Learning Management System that will be implemented from May to December 2010. The scholarship slots to be awarded for the 2010 program cycle is One Thousand Six Hundred Ten (1,610) to be allocated among the sixteen (16) regions at 100 scholarship slots per region and an additional 10 scholars shall be chosen by



DepEd Central Office. The program will be implemented following the schedule below:

- 5. Regional Directors are requested to identify/nominate participants who will attend this program based on the above-mentioned qualifications and schedule on or before April 15, 2010. A separate DepEd Memorandum shall be issued to announce the SEAMEO INNOTECH DepEd eXCELS III Scholars for 2010.
- 6. Tuition fee will be paid individually by each DepEd eXCELS III Scholar and charged to DepEd. Transportation to and from their station to the designated venues for orientation and revalida sessions and other allowable expenses will be charged to local funds subject to the usual accounting and auditing rules and regulations.
