CONDUCT OF A REGIONAL PLANNING ON THE EFFECTIVE
IMPLEMENTATION OF DISASTER RISK REDUCTION AND CLIMATE
CHANGE ADAPTATION PROGRAMS AND PROJECTS

To: All Regional Directors

1. As agreed during the Conference held on June 24, 2010, all Regional Directors are directed to conduct a 2-Day Regional Action Planning on the Effective Implementation of Disaster Risk Reduction and Climate Change Adaptation Programs and Projects within the month of July.
