**CONSULTATIVE MEETING OF REGIONAL SCIENCE SUPERVISORS**

To: Undersecretaries

Regional Directors

1. The National Science Teaching Instrumentation Center (NSTIC) is presently implementing a project on "Mass Production, Procurement and Delivery of Science Equipment, Laboratory Glassware and Consumables to the Recipient Public Secondary Schools" funded by Fifty Million Pesos (PhP50,000,000.00) and Four Hundred Thirteen Million Pesos (PhP413,000,000.00) funds.
2. To ensure that the recipient public secondary schools will have maximum utilization and can attain the expected useful life span of the equipment that will be distributed, a five-day Regional Training Workshop on the Use and Care with Content Integration of Science Equipment for science teachers of said schools will be held.
3. In view of this, the NSTIC will conduct a one-day Consultative Meeting with the Regional Science Supervisors on August 23, 2010 at the NSTIC Laboratory Room, Ecotech Compound, Sudlon, Lahug, Cebu City.
4. The objectives of the consultative meeting are to:
  - a. discuss the training design matrix that will be used during the regional training-workshop on the use and care of science equipment with content integration;
  - b. plan the training schedule of every region so that it will not affect its existing training programs in science;
  - c. discuss the logistical support that every region will provide such as the transporting of the science equipment from the selected schools (nearest to the venue) to the training venue. The number of sets of science equipment that will be used during the training will be determined by the NSTIC;
  - d. discuss and finalize the criteria in the selection of the regional trainers per science subject area;
  - e. discuss the conduct of the regional training of trainers for Integrated Science, Biology, Chemistry and Physics; and
  - f. discuss and clarify other related issues/concerns relative to the training of trainers and the regional training workshop.
5. The participants to the consultative meeting are the regional science supervisors of the seventeen (17) regions. Attendance is a must. The Regional Directors are directed to send their regional science supervisors to the aforesaid meeting.



6. Meals and snacks for the duration of the meeting will be provided by NSTIC while the travel expenses of the participants will be charged to local funds subject to the usual accounting and auditing rules and regulations.
