**ADDENDUM TO DEPED MEMORANDUM NO. 395, S. 2010  
(2010 Consultative Conference for the 282 Tech-Voc Secondary  
Schools Administrators on the Strengthened Technical  
and Vocational Education Program)**

Schools Division/City Superintendents

All Others Concerned

1. Paragraph No. 5 of DepEd Memorandum No. 395, s. 2010 is rephrased to read as follows:

***“The board and lodging of the participants are chargeable to OSEC Tech-Voc Education Funds, while their traveling expenses, per diems, and other incidental expenses are chargeable to local funds, subject to the usual accounting and auditing rules and regulations. However, the board and lodging, travel and per diem of project staff, resource persons, facilitators and secretariat, supplies and materials, training kit, function room rental, contingency and other incidental expenses are chargeable to OSEC Tech-Voc Education Funds, subject to the usual accounting and auditing rules and regulations.”***

2. Likewise, only thirty-three (33) Schools Division/City Superintendents of the Tech-Voc Public Secondary Schools without fiscal autonomy are invited to attend the said conference as specified in the enclosed list.

3. All the 282 Tech-Voc Secondary School Administrators/Principals and concerned Schools Division/City Superintendents and TLE/Tech-Voc Regional Supervisors (list enclosed to the abovementioned Memorandum) are requested to follow strictly the cluster/conference venue assigned to them in the 2010 Consultative Conference, for any change of schedule and venue will have an implication in the budgetary allocation per cluster, board and lodging of participants, and staff complementation.



4. The schedules and venues of the conference to be conducted in three (3) clusters are as follows:
