**CONSULTATIVE CONFERENCE AT THE REGIONAL LEVEL THROUGH THE CURRICULUM AND LEARNING MANAGEMENT DIVISION FOR ALL DIVISION ALTERNATIVE LEARNING SYSTEM FOCAL PERSONS, CURRICULUM IMPLEMENTATION DIVISION CHIEFS, PLANNING OFFICERS, INFORMATION TECHNOLOGY OFFICERS AND THE EDUCATION PROGRAM SPECIALIST FOR ALS**

To: Regional Directors  
Schools Division Superintendents  
Public Elementary and Secondary Schools Heads  
All Others Concerned

1. In line with the Department of Education's thrust of ensuring access to quality basic education for all Filipino learners, there is a need to strengthen the implementation of Alternative Learning System (ALS) nationwide. As a result of the National Consultative Conference regarding ALS Program held from August 29 to 31, 2016 at DepEd National Educators Academy of the Philippines (NEAP), Region XI, all regional directors (RDs) and schools division superintendents (SDSs) are advised to designate full-time focal person for ALS at the regional and division levels to ensure the effective and efficient implementation of the program. In this connection, all RDs are enjoined to conduct a **Consultative Conference at the Regional Level Through the Curriculum and Learning Management Division (CLMD) for All Division ALS Focal Persons, Curriculum Implementation Division (CID) Chiefs, Planning Officers, Information Technology (IT) Officers and the Education Program Specialists for ALS (EPSA)** on a date preferably not later than October 15, 2016 at a venue to be determined by the region.

2. The objectives of the Regional Consultative Conference are to:


- a. ensure reliable and accurate data as required in the Learner's Information System (LIS) which will be the basis for downloading of funds;
- b. address issues and concerns at the regional level regarding program implementation; and
- c. enhance the capacity of the schools division key personnel (CID chiefs, ALS focal person, EPSA, planning officer, and IT officer) regarding ALS program.

3. The funds for this activity shall be downloaded to the regional offices based on the target number of participants per region chargeable to the 2015 *Abot Alam* Funds. The allocated amount for each region shall cover the board and lodging; traveling expenses to and from the venue, including per diem of participants; and supplies and materials relative to the conduct of the activity, subject to the usual government accounting and auditing rules and regulation.

4. Enclosed is the matrix of funds allocation per region, including the expenditures relative to the conduct of the aforementioned consultative conference for the guidance of all concerned.


