REQUIRING SUBMISSION OF REPORT ON THE IMPLEMENTATION
OF EXECUTIVE ORDER NO. 26 DATED OCTOBER 7, 1992

To: Bureau Directors, Center Directors, Regional Directors,
and Schools Superintendents
Heads of Community Colleges and Universities
and Vocational Schools

1. For the information and guidance of the field and officials concerned, there is reproduced on the reverse side Memorandum Circular No. 26 of the Office of the President on the subject "Directing All Heads of Concerned Government Agencies to Report on Their Implementation of Executive Order No. 26 dated October 7, 1992".
2. The officials concerned are requested to comply with the requirement to submit the desired report which shall include the following:
 - a. Difficulties or problems encountered in carrying out the terms of Executive Order No. 26 dated October 7, 1992 "Prescribing Procedures and Sanctions to Insure Speedy Disposition of Administrative Cases".
 - b. Proposals and/or recommendations to remedy the same to aid the Office of the President in its evaluation of the effectiveness of the procedures and sanctions prescribed by the Order.
3. The report must be submitted within five (5) days from the receipt of this Order. Attention is invited to DECS Order No. 104, s. 1992 entitled "Dissemination of Executive Order No. 26 dated October 7, 1992".
4. Immediate dissemination of this Order is requested.

This Memorandum Circular shall take effect immediately.




