STRENGTHENING THE SYSTEM OF FIELD SUPERVISION INCLUDING
THE REASSIGNMENT OF REGIONAL DIRECTORS

1. POLICY OF REACHING OUT

The President has directed all government departments to further strengthen the delivery of basic services to the people, particularly to the poor and the disadvantaged. In line with this directive, it is hereby desired that all DECS officials shall go out of their way to reach out to their clientele and spend more time in solving problems of education in depressed rural and urban areas.

Let us make 1996 a banner year for achieving our basic education goals and make DECS a premiere department of the government.

The officials who have been reassigned shall effect a smooth turnover of their respective posts to their replacements


and report to their new stations not later than January 15, 1996.
