

**Regional Training on Interdisciplinary Contextualization (Icon)
for Mathematics Education**

To: Schools Division Superintendents

1. The Department of Education Regional Office VI and Science Education Institute of the Department of Science and Technology (DOST-SEI) in collaboration with the Mathematics Department of the West Visayas State University will hold a three-day training on “Interdisciplinary Contextualization (Icon) for Mathematics Education” live-out on March 20-22, 2017 at the West Visayas State University, La Paz, Iloilo City.
2. The 3-day regional training aims to capacitate mathematics teachers in developing lessons that are directly linked to day-to-day life experiences in the context of other disciplines. These methods of teaching and learning can strengthen the links between the learning environments of school, home, and community, which is very much attuned to the objectives of the K to 12 curriculum.
3. Participants in this training are selected Grades 7-10 mathematics teachers and division mathematics supervisors in the region. Participants are required to bring lap top, internet connectivity device, extension cord, CG and TG (Mathematics), Division Contextualized Matrix and reference materials. School heads should assign teachers to take over the participants teaching loads to ensure that classes are not missed.
4. School Division must submit or e-mail the list of their participants not later than March 10, 2017. Attached is the number of participants allotted per division and format for list of participants .
5. The Science Education Institute (SEI) shall provide training materials, certificates of completion, and meals (lunch and AM/PM Snacks) to participants for the duration of the training program.
6. Attendance of participants is on official business. Their travel expenses and per diem shall be charged against LOCAL FUNDS subject to the usual accounting and auditing rules and regulations.
