This pertains to the request of Hon. Shirlita Yu Chong, Municipal Mayor of Liloan, to use a portion of the Liloan Elementary School for purposes of constructing a Day Care Center building.

As per the records available in this office, the Liloan Elementary School site was donated to the Department of Education specifically for educational purposes. As per the 22 June 2015 ExeCom meeting, it was agreed that requests for construction of Day Care Centers within DepEd school sites cannot be granted as the needs addressed by Day Care Centers are different from the needs addressed by DepEd's regular public schools. Although Day Care Centers primarily cater to the educational needs of children aged 0 to 4, such needs are different from those of the regular schoolchildren that attend the Liloan Elementary School. Hence, the municipality's request cannot be granted.
