August 23, 2019

**WHEREAS**, the Department of Education, through the Asset Management Division, is in need of a supplier for the Supply, Delivery and Installation of Additional Air Conditioning Units for DepEd Central Office, with an estimated budget of **Philippine Pesos Four Million, Nine Hundred Seventy-Two Thousand, Four Hundred Fifteen and 20/100 (Php 4,972,415.20)** only, detailed as follows:

**WHEREAS**, the project is in the approved FY 2019 Annual Procurement Plan (APP) with Code Number AdmS2-011; a copy of the approved FY 2019 APP is attached and marked as Annex "A";

**WHEREAS**, copies of approved authority to procure dated October 31, 2018 and its attachments are attached and marked as Annex "B";

**WHEREAS**, assignments of the Provisional Members of the DepEd-Bids and Awards Committee (BAC) V for this project were approved through OO-OSEC-2019-018 dated February 21, 2019; members of the Technical Working Group (TWG) were designated through a memorandum dated June 14, 2019; copies of the memoranda are attached and marked as Annex "C";

**WHEREAS**, the DepEd-BAC V conducted a pre-procurement conference on May 31, 2019 at the Office of the Assistant Secretary for Finance Conference Room, Ground Floor, Bonifacio Bldg., Meralco Ave., Pasig City, to discuss the project's final technical specifications, ABC, and schedule of requirements with the end-user; a copy of the Minutes of Pre-Procurement Conference is attached and marked as Annex "D";

**WHEREAS**, the BAC Secretariat posted an Invitation to Bid (IB) in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference No. 6261058,

DepEd Website and Bulletin Board last June 19, 2019; copies of the IB, PhilGEPS Bid Notice Abstract, and DepEd Website and bulletin board postings are attached and marked as Annex "E";

**WHEREAS**, two (2) prospective bidders namely: 1) Innovalite Inc., and 2). ACMI Office Systems Philippines, Inc. availed of the Bidding Documents which were made available starting on June 19, 2019; copies of a set of the Bidding Documents and Bidder's Information Sheet are attached and marked as Annex "F";

**WHEREAS**, invitations were sent to the BAC V, Asset Management Division, Commission on Audit (COA), CSOs –National Citizens' Movement for Free Elections (NAMFREL), Transparency International – Philippines (TIP), Philippine Chamber of Commerce and Industry (PCCI) and ANSA-EAP Foundation, Inc. to attend the procurement activities; copies of the Schedule of DepEd-BAC Procurement Activities 2018-032 and invitations dated June 19, 2019 are attached and marked as Annex "G";

**WHEREAS**, two (2) prospective bidders attended the pre-bid conference last July 8, 2019, 1:00 P.M. at the BCD Conference Room, Third Floor, Bonifacio Bldg., DepEd Complex, namely: (1) Innovalite, Inc. and (2) Golden 3T Construction, Corp.; copies of the Minutes of Pre-Bid Conference, Bid Bulletin Nos. 1, 2, 3, 4 and 5 dated June 25, 2019, July 1, 2019, July 3, 2019, July 22, 2019 and July 26, 2019 respectively, and DepEd bulletin board postings are attached and marked as Annex "H";

**WHEREAS**, on the deadline of submission and opening of bids last August 1, 2019, 10:00 A.M., at BCD Conference Room, Bonifacio Bldg., DepEd Complex; two (2) bidders submitted its bid, namely: 1) Innovalite, Inc.; and 2) ACMI Office Systems Philippines, Inc.; copies of the Minutes of Bid Opening, Checklists for Bid Opening, Abstract of Bids As Read, and Notices of Receipt of Bid and bidders' bids are attached and marked as Annexes "I", "J", "K", and "L" and "M", respectively;

**WHEREAS**, on even date, at the BCD Conference Room, Bonifacio Bldg., DepEd Complex, the BAC convened, discussed the detailed bid evaluation results and declared ACMI Office Systems Philippines, Inc. as the bidder having the lowest calculated bid; a copy of the Bid Evaluation Report / Abstract of Bids As Calculated is attached and marked as Annexes "N";

**WHEREAS**, on even date, Notice of Having the Lowest Calculated Bid was sent to ACMI Office Systems Philippines, Inc.; a copy of the notice is attached and marked as Annex "O";

**WHEREAS**, on August 13, 2019, Engr. Mark Joseph L. Calilung (member of Technical Working Group) and Ms. Phoebe Ann R. Wagan (BAC Secretariat) conducted post-qualification inspection on ACMI Office Systems Philippines, Inc.; ACMI Office Systems Philippines, Inc. also submitted its post-qualification documents which were found to be complete;

**WHEREAS**, on August 19, 2019, the Bids and Awards Committee V, thru the BAC Secretariat, received a memorandum dated August 16, 2019 informing the BAC V of the End-User's decision to cancel the project "due to the transfer of Central Office to another location"; copies of the Authority to Travel, Inspection Report, Post-Qualification documents and memorandum are attached and marked as Annex "P";

**WHEREFORE**, all premises considered, the Bids and Awards Committee (BAC) V hereby recommends to the Head of Procuring Entity the cancellation of the project, pursuant to Section 41(c) of the Republic Act 9184 and its Implementing Rules and Regulation, which states that "*the Hope reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract in the following situations: xxx c) For any*

justifiable and reasonable ground where the award of the contract will not redound to the benefit of the GoP, as follows: xxx (i) if the physical and economic conditions have significantly changed so as to render the project no longer, economically, financially, or technically feasible, as determined by the HoPE; xxx.”
