**CALL FOR PROPOSALS FOR THE 2020 NATIONAL COMMISSION FOR CULTURE
AND THE ARTS GALLERY AND EXHIBITION PROGRAM**

1. Pursuant to its mandate to extend recognition to and to promote the popularization of artistic achievements, the National Commission for Culture and the Arts (NCCA) is now accepting proposals for the **2020 NCCA Gallery and Exhibition Program**.

2. Since 2009, the NCCA Gallery, located at the lobby of the NCCA Building in Intramuros, has been offering an exhibition space, which provides young and emerging artists a venue for exposure without curtailing creative exploration and expression. Likewise, established artists are given the opportunity to share their conceptual narratives with the audience and encourage engagements in the arts.

3. Exhibition proposals may be submitted by any Filipino citizen, any group or institution based in the Philippines. Such proposals shall be accepted only when these are submitted in writing and with proper supporting documentation, as follows:

- a. A cover page containing the exhibit title, name of applicant (individual or group), type of exhibition (solo or group), and contact details;
- b. A curatorial brief, which shall contain the description and summary of the exhibition, and how the space will be utilized;
- c. Artist/s portfolio inclusive of updated bio data, digital photographs or sample artworks each properly labeled with details, and any previous write-up about the artist/s; and
- d. Statement of the artists about the proposed exhibition.


4. Deadline of submission is on **July 31, 2019**. Exhibition proposals received beyond the announced deadline for the submission shall not be considered.
