**INVITATION TO BID**

FOR THE

**Mass Production, Supply and Delivery for Various Tools and Equipment for 9,069 Technical-Vocational-Livelihood (TVL) Programs of 2,195 TVL Senior High Schools**

- The Department of Education (DepEd), through the Government of the Philippines (GOP) under FY 2018 General Appropriations Act (GAA),<sup>1</sup> intends to apply the sum of **Philippine Pesos Two Hundred Forty-Three Million Six Hundred Forty-One Thousand Four Hundred Ninety-Nine 36/100 (Php 243,641,499.36)**, to payments under the contract for the Mass Production, Supply and Delivery for Various Tools and Equipment for 9,069 Technical-Vocational-Livelihood (TVL) Programs of 2,195 TVL Senior High Schools, broken down as follows:

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- DepEd, through its Bids and Awards Committee V, now invites bids for the goods and services contemplated in this project and as detailed in the Schedule of Requirements and

the table of Technical Specifications indicated in the bidding documents.<sup>2</sup> Delivery of the Goods is required within 310 days from issuance of the Notice to Proceed. Bidders should have completed, within ten (10) years immediately preceding the deadline for the submission of bids, at least two (2) contracts similar to the Project, the aggregate applicable contract amount being equivalent to at least fifty percent (50%) of the ABC of the lot bid for, and the largest of those said contracts is equivalent to twenty-five percent (25%) of the said ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the **BAC Secretariat, DepEd Procurement Management Service**, and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00am to 5:00pm**.
5. *A complete set of Bidding Documents may be acquired in the amount of Philippine Pesos Thirty Thousand and 00/100 (PhP 30,000.00) by interested Bidders October 5, 2018 from the address below upon payment of fees.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The DepEd will hold a Pre-Bid Conference<sup>3</sup> on **October 12, 2018, 1:00 P.M.** at **Bulwagan ng Karunungan, Ground Floor, Rizal Bldg., DepEd Complex, Meralco Avenue, Pasig City.**, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **9:00 A.M. of October 26, 2018**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **October 26, 2018, 9:00 A.M.** at **Bulwagan ng Karunungan, Ground Floor, Rizal Bldg., DepEd Complex, Meralco Avenue, Pasig City..** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. DepEd reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
