VI. LIQUIDATED DAMAGES

If the **Consultant** fails to satisfactorily perform the Services within the period(s) specified in the Contract inclusive of duly granted time extensions, if any, the **Procuring Entity** shall, without prejudice to its other remedies under the Contract and under applicable laws, deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one (1) percent of the cost of the unperformed portion for every day of delay until the actual performance by the **Consultant**. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum deduction is reached, the **Procuring Entity** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available to the **Procuring Entity**.
