WHEREAS, the project is in the approved CY 2019 Annual Procurement Plan (APP) under the code BLR2-001; a copy of the approved CY 2019 APP is attached and marked as Annex "A";

WHEREAS, copies of approved authority to procure dated February 11, 2019 and its enclosures are attached and marked as Annex "B";

WHEREAS, assignment of the Provisional Members of the DepEd-Bids and Awards Committee (BAC) III for this project was approved through OO-OSEC-2019-018 dated February 21, 2019; a copy of the Office Order is attached and marked as Annex "C";

WHEREAS, the BAC Secretariat posted a Request for Expression of Interest (REI) in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference Nos. 6571098, and Bulletin Board last October 21, 2019; copies of the Minutes of Pre-Procurement Conference dated October 16, 2019, REI, PhilGEPS Bid Notice Abstract, DepEd website posting and bulletin board posting, and Bidding Documents (Part 1) are attached and marked as Annex "D";

WHEREAS, members of the Technical Working Group (TWG) were designated through a resolution dated October 21, 2019; a copy of the resolution designating the TWG is attached and marked as Annex "E";

WHEREAS, last October 24, 2019, 3:30 P.M., at the Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Avenue, Pasig City, three (3) prospective bidders attended the pre-eligibility conference; copies of Minutes of Pre-Eligibility Conference, and Bid Bulletin Nos. 1 to 5 and bulletin board postings are attached and marked as Annex "F";

WHEREAS, on the deadline of submission and opening of eligibility documents last November 11, 2019, 10:30 A.M., at the Bulwagan ng Karunungan, Ground Floor, Rizal Building, DepEd Complex, Meralco Avenue, Pasig City, three (3) bidders submitted their eligibility documents, namely, (1) Vibal Group, Inc., (2) SC Mardison Corporation, and (3) Rex Bookstore, Inc.; copies of Minutes of Eligibility Opening and Checklists for Eligibility Opening are attached and marked as Annexes "G" and "H", respectively;

WHEREAS, the TWG evaluated the eligibility documents last November 11-13, 2019 at the Education Facilities Division (EFD) Conference Room, 5th Floor, Mabini Building, DepEd Complex, Meralco Avenue, Pasig City;

WHEREAS, last November 14, 2019, the BAC discussed the results of the evaluation conducted by the TWG; all bidders passed the evaluation on the lots they bid for; copies of Minutes of BAC Meeting and evaluation results are attached and marked as Annex "I";

WHEREAS, on even date, the BAC Secretariat presented in advance the draft copies of the Minutes of Meetings (based on the notes taken by the BAC Secretariat during the proceedings) and Resolution for Shortlisting to the BAC members present namely, Usec. Tonisito M.C. Umali, Esq, BAC III Chairperson, Dir. Jocelyn DR. Andaya, Regular Member, and Dir. John Arnold S. Siena, Provisional Member; the BAC approved aforementioned

documents and authorized the BAC Secretariat to affix their e-signatures once finalized consistent with the Government Procurement Policy Board (GPPB) Resolution No. 16-2019, if necessary;
