I. Section I, Invitation to Bid, Item 7, Page 9 and Section III, Bid Data Sheet, ITB Clauses 21 and 24.1, Pages 59 and 60, respectively, are hereby revised, to wit;

The deadline for submission of bids is November 26, 2019; 9:00 A.M.

The place of bid opening is Internal Audit Service Conference Room, G/F, Mabini Bldq., DepEd Complex, Pasig City.

The date and time of bid opening is November 26, 2019; 9:00 A.M.

II. Section III, Bid Data Sheet, ITB Clauses 20.2, Page 59:

The sealing and marking of bids is hereby revised, to wit;

The inner and outer envelopes of the Technical Component and the Financial Component of the bids shall be marked in accordance with ITB Clause 20.4

To facilitate the receipt and classification of bid envelopes, outer envelopes shall be color RED, inner envelope containing Technical Proposal shall be color Blue and inner envelope containing Financial Proposal shall be color Green.

The following documents which are to be submitted as part of the bids must be produced in electronic forms recorded on three (3) CDs/flash drive (both Word format and PDF (or read-only) format)

- 1. Statement of Compliance with Technical Specifications
- 2. Filled out Price Schedule
- 3. Filled out Net Financial Contracting Capacity (NFCC)

In case of discrepancy in the substance and content between the printed copies and the CDs/**flash drive**, the printed copies shall prevail. Non-submission of CDs/**flash drive** will not be a ground for disqualification, but the bidder may be required to submit the same during the opening of the financial envelopes.

Post qualification documents may be submitted during the bidding but this does not disqualify bidders who will not submit post qualification documents during bid submission.

III. Section V, Special Conditions of Contract, GCC Clause 10.3, Page 89;

"Progress Payment of 15% shall be paid to the Supplier from the total contract price upon delivery and acceptance of the Goods at the Project/s Site and upon submission of the documents (i) to (iii) specified in SCC for GCC Clause 6.2 and other documents required in government accounting and auditing rules and regulations", is hereby deleted.
