SUBJECT : **Suspension of the National eHealth Electronic Health/Medical Record System Validation Operations on Department of Health Central Office, Centers for Health Development (CHDs) of Metro Manila, CALABARZON and MIMAROPA**

Pursuant to the *Inter-Agency Task Force for the Management of Emerging Infectious Disease Resolution No. 11 Series of 2020* dated 12 March 2020, which imposes a 30-day community quarantine on Metro Manila starting 12 March 2020 up to 12 April 2020, the conduct of National eHealth Electronic Health/Medical Record System Validation (NEHEHRSV) on the DOH Central Office, CHDs of Metro Manila, CALABARZON and MIMAROPA shall be suspended and will continue its conduct on **13 April 2020 onwards**, unless lifted by the Office of the President. As such, all applicants scheduled on those mentioned dates **are cancelled and must request for re-schedule at the NEHEHRSV website: ehealth.doh.gov.ph/nehehsv.**

CHDs not affected by the imposed community quarantine shall continue the NEHEHRSV operations in their respective regions, unless otherwise advised by their Local Government Units. Rest assured that the Central NEHEHRSV team shall still continue to support the regional operations amidst this public health threat.
