Consistent with the provisions of DepEd Order No. 32, s. 2017, "Gender-Responsive Basic Education Policy", which set forth the realization of international and national commitments and action plans on gender equality and women empowerment, this Region hereby requests the field for submission of **Consolidated Division GAD Plans and Budgets (GPB) for FY 2021 (including those of the schools, SY 2021-2022)**.

As per Philippine Commission on Women - National Economic and Development Authority- Department of Budget and Management (PCW-NEDA-DBM) Joint Circular No. 2012-01, "Guidelines for the Preparation of Annual GAD Plans and Budgets (GPB) and Accomplishment Reports (AR) to Implement the Magna Carta for Women", GAD activities shall constitute at least five percent (5%) of the total agency budget appropriations authorized under the annual General Appropriations Act (GAA). In view of this, all Schools Division Offices shall ensure compliance to the required GAD budgetary allocation in terms of plans and programs.

Likewise, schools shall submit soft copies of their GPB (in Excel file) to their respective Schools Division Office for consolidation. Schools Division Offices shall then submit the Consolidated Division GPB to the Region via online at neapncrhrdd@gmail.com on or before **March 24, 2020**. The Consolidated Regional GPB shall be encoded to the Agency-Wide Gender Mainstreaming Monitoring System (GMMS) for review and indorsement to the PCW.
