WHEREAS, the Department of Education (DepEd), through the Bureau of Learning Resources – Learning Resources Quality Assurance Division (BLR-LRQAD), is in need of a service provider for the Quality Assurance of Quarter 2 SLMs, Radio/Audio Scripts, and TV/Video Scripts with a total estimated budget of **Philippine Pesos Eighteen Million, Eight Hundred Eighteen Thousand, Four Hundred and 00/100 (PhP 18,818,400.00)** only;

WHEREAS, the project is in approved 2020 Annual Procurement Plan (APP) with Code Number BLR3-001; copy of the APP is attached and marked as Annex “A”;

WHEREAS, copies of the approved authority to procure dated September 10, 2020 and other pertinent documents are attached and marked as Annex “B”;

WHEREAS, assignment of the provisional members of the DepEd-Bids and Awards Committee (BAC) V for this project was approved through Office Order dated February 27, 2020 and designation of Mr. Francis Allen B. Dela Cruz was approved through Office Order dated October 1, 2020; copies of the Office Order are attached and marked as Annex “C”;

WHEREAS, on October 22, 2020, the BAC convened and reviewed the submitted proposals, the BAC instructed the End-User to submit a market survey to show comparison of the delivery of services offered by at least three (3) different universities; and on November 3, 2020, the BAC determined that the proposed method is efficient and economical; copies of the end-user’s justification, market survey and terms of reference are attached and marked as Annex “D”;

WHEREAS, the end-user shall engage the services of **Philippine Normal University (PNU)**, located at 104, Taft Avenue, Ermita, Metro Manila which certified that a) PNU has the mandate to render the services and facilities required for this project; and b) PNU has complied with all the required general conditions as provided for in Annex H of the CY 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A) 9184; copies of certifications and proposals (Quality Assurance of Quarter 2 SLMs, Radio/Audio Scripts, and TV/Video Scripts) from Philippine Normal University are attached and marked as Annex “E”;



WHEREAS, Negotiated Procurement – Agency to Agency is provided under Section 53.5 of the IRR of R.A. 9184 for the procurement of consulting services from another agency of the Government of the Philippines (GOP), as an alternative mode of procurement;


WHEREAS, per proposal of the end-user, the BAC initially recommended the award in the amount of **Philippine Pesos Nineteen Million, One Hundred Fifty-Two Thousand and 00/100 (PhP 19,152,000.00)** only, which was already approved by the Head of Procuring Entity (HoPE) through a Resolution to Award dated November 23, 2020;

WHEREFORE, all premises considered, the Committee resolves, as it is hereby resolved to recommend to the Secretary of Education, to award the procurement of service provider for the above-mentioned project through Negotiated Procurement (Agency-to-Agency) in accordance with Section 53.5 of R.A. 9184 and Annex H of its IRR, to **Philippine Normal University (PNU)** in the total amount of **Philippine Pesos Eighteen Million, Eight Hundred Eighteen Thousand, Four Hundred and 00/100 (PhP 18,818,400.00)** only, inclusive of VAT.


