CONTRACT AGREEMENT

22 JUN 2021
THIS AGREEMENT made and entered into this ____ day of _____ 2021 by and between **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, Philippines, represented herein by its Undersecretary, **DIOSDADO M. SAN ANTONIO**, as per DepEd Order No. 023, s. 2021 (hereinafter referred to as “**DEPED**”); and **FORGEMS MARKETING COMPANY, INC. IN JOINT VENTURE WITH LG&M CORPORATION** represented herein by its Authorized Representative, **CELINE MARIE T. MONTALLA**, with office address at 8C Cortijos Condominium, 25 Eisenhower St., San Juan City, Metro Manila, Philippines (hereinafter referred to as “**FORGEMS JV LG&M**”).

DEPED and FORGEMS JV LG&M are collectively called “PARTIES.”

WHEREAS, DEPED invited bids for the development, printing and delivery of Self-Learning Modules Quarter 4 consisting of sixty (64) Line Items and received bids from twenty-nine (29) bidders; **DEPED** opened, read, and evaluated the bids of the twenty-nine (29) bidders and declared **FORGEMS JV LG&M** as having the lowest calculated bid for Line Item No. **22**; after evaluation, **DEPED** post-qualified and declared the bid of **FORGEMS JV LG&M** as the lowest calculated responsive bid for Line Item No. **22** in the sum of **PHILIPPINE PESOS THIRTY-EIGHT MILLION, FOUR HUNDRED TWENTY-FIVE THOUSAND, ONE HUNDRED FIFTEEN and 61/100 (PhP 38,425,115.61) ONLY**, (hereinafter called the “Contract Price”) detailed as follows:

2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:

 - c. General and Special Conditions of the Contract; and
 - d. Bid Bulletin No. 1 dated 24 April 2021.

- ii. **FORGEMS JV LG&M's** bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
- iii. Performance Security;
- iv. Notice of Award of Contract and **FORGEMS JV LG&M's** conforme thereto; and
- v. Other contract documents required by existing laws and/or **DEPED** in the PBD. **FORGEMS JV LG&M** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.

3. The contract shall be performed in accordance with the delivery schedules indicated in the Notice to Proceed (NTP), or in any subsequent instruction duly issued by **DEPED**.

4. **FORGEMS JV LG&M** shall post a Performance Security within ten (10) calendar days from receipt of the Notice of Award in the form and amount prescribed therein. The performance security shall be posted in favor of **DEPED**, and shall be forfeited in the event it is established that **FORGEMS JV LG&M** is in default of any of its obligation under this contract. **FORGEMS JV LG&M** shall be responsible for the extension of its performance security and/or undertake to renew its performance security whenever necessary, and without need of prior notice or instruction from the **DEPED**, to ensure that it is in force and effect for the whole duration of the contract and until a Certificate of Final Acceptance is duly issued.

Any proposal to deliver items of equivalent, higher or superior technical specifications, in lieu of the abovestated, shall be discretionary to **DEPED** and is subject to the evaluation and recommendation of the end-user or implementing units and the approval of the herein authorized representative and signatory.

- Goods with defects or non-compliant with the required specifications shall be rejected by **DEPED** and replaced by **FORGEMS JV LG&M** in accordance with the warranty provisions in the bidding documents. **DEPED** shall have the option to inspect **FORGEMS JV LG&M's** premises

covered by the Contract, at any time or stage of contract implementation, to monitor and assess **FORGEMS JV LG&M's** capacity to discharge its contractual obligations.

7. The procured goods or items contemplated under this Contract shall be inspected by **DEPED** Inspectorate Team duly constituted for this Project prior to delivery to the project sites in accordance with the provisions of the Special Conditions of the Contract, the Schedule of Requirements, or otherwise indicated in other parts of the bidding documents.

8. **FORGEMS JV LG&M** shall deliver the goods in accordance with the Delivery Schedule to the various project sites as indicated in the Distribution List. Goods delivered to sites other than those indicated in the Distribution List without **DEPED's** written authorization and/or approval may be rejected by the latter. Violation of this provision, based on documents and reports submitted and validated by the authorized receiving personnel may be a cause for the termination of the Contract.

9. In case **FORGEMS JV LG&M** encounters condition(s) impeding timely delivery of the goods, **FORGEMS JV LG&M** shall promptly notify **DEPED** in writing of such condition(s). As a rule and on account of the emergency nature of this project, no work suspensions and/or contract delivery period extension shall be allowed.

10. The Contract Price shall be paid to **FORGEMS JV LG&M** in accordance with the following disbursement procedures:

10.1. An advance payment not to exceed fifteen percent (15%) of the Contract Price shall be allowed and paid within sixty (60) calendar days from signing of the contract. An irrevocable Letter of Credit or Bank Guarantee of an equivalent amount must be submitted, and shall remain valid until the goods are delivered, and accompanied by a claim for advance payment.

10.2. **FORGEMS JV LG&M** may submit a request for payment based on Progress Reports which shall be attached to the progress billing and include the following: (i) cumulative quantities of items delivered based on the schedule of deliveries and other relevant terms and conditions of the Contract; (ii) Inspection and Acceptance Reports (IARs), including certification by **FORGEMS JV LG&M**, duly signed and dated by the authorized representative of the **DEPED** indicating that the items have been delivered in accordance with the Contract. Other documents in support of a request for payment may be prescribed by **DEPED**



pursuant to existing disbursement, accounting and auditing rules and procedures.

10.3. Subject to the recoupment of the advance payment contemplated in Clause 10.1. above, and retention contemplated in the immediately succeeding clause, payment shall be made to **FORGEMS JV LG&M** within sixty (60) days from submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by **DEPED**, in the following manner:

10.3.1. For the initial progress payment, a minimum of twenty-five percent (25%) of the Contract Price of the line item shall be paid to **FORGEMS JV LG&M** upon a minimum of twenty-five percent (25%) delivery and acceptance of the items by **DEPED's** authorized representative;

10.3.2. Final payment shall constitute release of the retention money in case of expiry of the warranty period, or whatever is left of it, after it has been called for use under the warranty provision.

11. Payments shall be subject to the "Warranty" provision in the form of either retention money in an amount equivalent to at least one percent (1%) of every progress payment or a Special Bank Guarantee in the amount equal to at least one percent (1%) of the Contract Price required under Section 62 of R.A. 9184 and its revised IRR.

12. **FORGEMS JV LG&M** shall be liable for liquidated damages for the delay in its performance in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery, for every day of delay until such goods are finally delivered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **FORGEMS JV LG&M**, or collect from any of the securities or warranties posted by **FORGEMS JV LG&M**, whichever is convenient to **DEPED**. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the Contract Price, **DEPED** may rescind or terminate the Contract, without prejudice to other courses of action and remedies available under the circumstances.

13. Subcontracting of any portion of the Project, which must not be more than twenty percent (20%) of the contracted goods, shall not relieve **FORGEMS JV LG&M** of any liability or obligation under this Contract. **FORGEMS JV LG&M** shall be responsible for the acts, default or negligence of any subcontractor and its agents, servants or workmen as

fully as if these were **FORGEMS JV LG&M's** own acts, default or negligence, or those of its agents, servants or workmen.

14. The **PARTIES** shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the Parties in connection with the implementation of the Agreement. Should such dispute not be resolved amicably, it shall be submitted to arbitration in the Philippines according to the provisions of Presidential Decree No. 242 and Executive Order No. 292. Provided, however, that by mutual agreement, the Parties may agree in writing to resort to other alternative modes of dispute resolution.
