WHEREAS, the Department of Education (DepEd), through the Bureau of Learner Support Services- School Sports Division (BLSS-SSD), is in need of consulting firm for the Professional and Consultancy Services for the Technical Training, Ideation, Production and Distribution of the Video Lessons for DepEd TV, Creation of DepEd TV Brand Book and Personality Development of its Teacher Broadcasters with a total approved budget for the contract (ABC) in the amount of Philippine Pesos Thirty Million and 00/100 only (PhP30,000,000.00) only.

WHEREAS, the project is in the approved CY 2021 Annual Procurement Plan (APP); a copy of the approved APP is attached and marked as Annex "A";

WHEREAS, the DepEd-BAC I conducted pre-procurement conference on October 28, 2021 through videoconferencing using MS Teams to discuss the project's specifications or terms of reference, shortlisting and technical evaluation criteria, market survey and ABC with the end-user; copy of the Minutes of Pre-Procurement Conference is attached and marked as Annex "D";

WHEREAS, the BAC Secretariat posted a Request for Expression of Interest (REI) in the Philippine Government Electronic Procurement System (PhilGEPS) with Reference Nos. 8139699, DepEd Website and DepEd Bulletin Board last October 30, 2021; copies of the REI, PhilGEPS Bid Notice Abstract, DepEd website and bulletin board postings, and Bidding Documents are attached and marked as Annex "E";

WHEREAS, invitations were sent to the BAC I, Assistant Secretary for Procurement and Administration, Procurement Management Service-Office of the Director, BLSS- School Sports Division, Technical Working Group, Cash Division, Education Programs Delivery Unit, Public Affairs Service, Commission on Audit (COA), National Citizens' Movement for Free Elections (NAMFREL), ANSA-EAP Foundation, Inc., Philippine Chamber of Commerce and Industry (PCCI) and

WHEREAS, on November 5, 2021, 1:00 P.M., thru videoconferencing using MS Teams, two (2) prospective bidders, namely: (1) EI2 Tech Inc. and (2) Adrow Creatives, Inc. attended the pre-eligibility conference; copy of the Minutes of Pre-Eligibility Conference is attached and marked as Annex "G";

WHEREAS, on the deadline of submission and opening of eligibility documents on November 9, 2021, 9:00 A.M. and 10:00 A.M., respectively at the BCD Conference Room, Third Floor, Bonifacio Building, DepEd Complex, Meralco Avenue, Pasig City, two (2) bidders submitted their eligibility documents, namely, (1) JV of Radenta Technologies Inc. and EI2 Tech, Inc. and (2) Adrow Creatives Inc.; Adrow Creatives, Inc. was declared disqualified for failure to submit audited financial statement; copies of Minutes of Eligibility Opening and Checklists for Eligibility/Shortlisting are attached and marked as Annexes "H" and "I", respectively;

WHEREAS, on even date, the TWG evaluated the eligibility documents; copy of the Evaluation Report is attached as Annex "J";

WHEREAS, on November 15, 2021, the BAC discussed the results of the evaluation conducted by the TWG; JV of Radenta Technologies Inc. and EI2 Tech, Inc. passed the evaluation; copy of Minutes of BAC Meeting is attached and marked as Annex "K";

WHEREFORE, all premises considered, the Committee resolves as it is hereby resolved to recommend to the Secretary of Education, the shortlisted consulting firm for the Professional and Consultancy Services for the Technical Training, Ideation, Production and Distribution of the Video Lessons for DepEd TV, Creation of DepEd TV Brand Book and Personality Development of its Teacher Broadcasters that passed the minimum 70.00% rating, to wit:
