**CONTRACT AGREEMENT**

**THIS AGREEMENT** made and entered into this \_\_\_\_ day of **FEB 22 2022** 2022 by and between **DEPARTMENT OF EDUCATION**, located at DepEd Complex, Meralco Avenue, Pasig City, Philippines, represented herein by its Secretary, **LEONOR MAGTOLIS BRIONES**, as per Department Order No. 023, s. 2021 (hereinafter referred to as "DEPED"); and **METRO MOBILIA CORPORATION IN JOINT VENTURE WITH ZHEJIANG SUNFLOWER EDUCATIONAL EQUIPMENT CO., LTD.**, represented herein by its authorized representative, **ENERO P. MAGTOTO**, with office address at 7<sup>TH</sup> Floor, Asian Start Building, ASEAN Drive, Corner Singapura Lane, Filinvest Corporate City, Alabang, Muntinlupa City, Philippines (hereinafter referred to as "THE JOINT VENTURE").

DEPED and THE JOINT VENTURE are collectively called "PARTIES."

WHEREAS, DEPED invited bids for the Supply and Delivery of School Furniture for Elementary, Junior, Senior High Schools CY 2021 School Furniture Program consisting of eighteen (18) lots, and received bids from fifteen (15) bidders; DEPED opened, read, and evaluated the bids of the fifteen (15) bidders and declared THE JOINT VENTURE as having the lowest calculated bid for the above-captioned project for Lot No. 6; after evaluation, DEPED post-qualified and declared the bid of THE JOINT VENTURE as the lowest calculated responsive bid for Lot No. 6 in the sum of **PHILIPPINE PESOS EIGHTY-FOUR MILLION, SEVEN HUNDRED TWELVE THOUSAND, THREE HUNDRED FORTY-FOUR and 22/100 (PhP 84,712,344.22) ONLY**, (hereinafter called the "Contract Price") detailed as follows:

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to;
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz:
  - i. Philippine Bidding Documents (PBD);
    - a. Schedule of Requirements;
    - b. Technical Specifications;
    - c. General and Special Conditions of the Contract; and
    - d. Bid Bulletin No. 1 dated November 22, 2021.
  - ii. **THE JOINT VENTURE's** bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Performance Security;
  - iv. Notice of Award of Contract and **THE JOINT VENTURE's** conforme thereto; and
  - v. Other contract documents required by existing laws and/or DepEd in the PBD. **THE JOINT VENTURE** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Order, and Warranty Security, shall form part of the Contract.
3. The goods supplied by **THE JOINT VENTURE** under this Contract shall be picked-up or hauled by the third-party logistics provider designated by **DEPED**. Risk and title to the Goods shall pass from **THE JOINT VENTURE** to **DEPED** upon receipt and final acceptance at **THE JOINT VENTURE's** warehouse.
4. The goods shall be ready for pick-up or hauling by the third-party logistics provider **on or before March 15, 2022** from receipt of **THE JOINT VENTURE** of Notice to Proceed (NTP) or within the period as may be prescribed in the NTP.
5. **THE JOINT VENTURE** shall post a Performance Security within ten (10) calendar days from receipt of the Notice of Award in the form and amount prescribed therein. The performance security shall be posted in favor of **DEPED**,

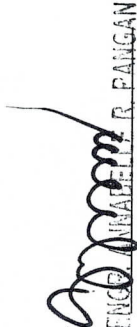

and shall be forfeited in the event it is established that **THE JOINT VENTURE** is in default of any of its obligation under this contract. **THE JOINT VENTURE** shall be responsible for the extension of its performance security and/or undertake to renew its performance security whenever necessary, and without need of prior notice or instruction from the **DEPED**, to ensure that it is in force and effect for the whole duration of the contract and until a Certificate of Final Acceptance is duly issued.

6. The goods supplied under this Contract should conform to and comply with the standards mentioned in Section VI. Schedule of Requirements of the Bidding Documents, as amended by Bid Bulletin No. 1 dated 22 November 2021, and must be in accordance with the technical specifications of the items, a copy of which is hereto attached as Annex "A" and made an integral part hereof. Any proposal to deliver items of equivalent, higher, or superior technical specifications in lieu of those of the approved bids or samples shall be discretionary to **DEPED** and is subject to the evaluation and recommendation of the end-user or implementing units and the approval of the herein authorized representative and signatory.

7. Goods with defects or non-compliant with the required specifications shall be rejected by **DEPED** and replaced by **THE JOINT VENTURE**. **DEPED** shall have the option to inspect **THE JOINT VENTURE's** premises covered by the Contract, at any time or stage of contract implementation, to monitor and assess **THE JOINT VENTURE's** capacity to discharge its contractual obligations.

8. The procured goods or items contemplated under this Contract shall be inspected by the duly designated **DEPED** Inspectorate Team prior to hauling by the third-party logistics provider in accordance with the Special Conditions of the Contract and the applicable provisions of DepEd Inspection and Acceptance Protocols (DepEd Order No. 041, s. 2021).

9. In case **THE JOINT VENTURE** encounters condition(s) impeding timely delivery of the goods, **THE JOINT VENTURE** shall promptly notify **DEPED** in writing of such condition(s). As a rule and on account of the emergency nature of this project, no work suspensions and/or contract delivery period extension shall be allowed.

10. The Contract Price shall be paid to **THE JOINT VENTURE** in accordance with the following disbursement procedures:

10.1 An advance payment not to exceed fifteen percent (15%) of the Contract Price shall be allowed and paid within sixty (60) calendar days from the signing of the contract. An irrevocable Letter of Credit or Bank

Guarantee of an equivalent amount must be submitted and shall remain valid until the goods are delivered and accompanied by a claim for advance payment.

10.2 THE JOINT VENTURE may submit a request for payment based on Progress Reports which shall be attached to the progress billing and include the following: (i) cumulative quantities of items delivered based on the schedule of deliveries and other relevant terms and conditions of the Contract; (ii) Inspection and Acceptance Reports (IARs), including certification by THE JOINT VENTURE duly signed and dated by the authorized representative of the DEPED indicating that the items have been delivered in accordance with the Contract. Other documents in support of a request for payment may be prescribed by DEPED pursuant to existing disbursement, accounting and auditing rules and procedures.

10.3 Subject to recoupment of the advance payment contemplated in Clause 10.1. above, and retention contemplated in the immediately succeeding clause, payment shall be made to THE JOINT VENTURE within sixty (60) days from submission of the documents specified in SCC Clause 2.2 and other documents as may be prescribed by DEPED, in the following manner:

10.3.1. For the initial progress payment, a minimum of twenty-five percent (25%) of the Contract Price shall be paid to THE JOINT VENTURE upon a minimum of twenty-five percent (25%) delivery and acceptance of the items by DEPED's authorized representative;

10.3.2. Final payment shall constitute a release of the retention money in case of expiry of the warranty period, or in case of use in part of the retention money by reason of a call upon the warranty, the final payment shall constitute the release of the balance amount.

11. Payments shall be subject to the "Warranty" provision in the form of either retention money in an amount equivalent to at least three percent (3%) of every progress payment, or a Special Bank Guarantee in the amount equal to at least three percent (3%) of the Contract Price as required under Section 62 of R.A. 9184 and its revised IRR.

11.1 A comprehensive and onsite warranty of one (1) year for durability based on stress test and of two (2) years against woodborer for the procured items will be applied. The said warranty periods shall reckon




from the date of issuance of Certificate of Final Acceptance by the **DEPED**.

12. **THE JOINT VENTURE** shall be liable for liquidated damages for the delay in its performance in an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery, for every day of delay until such goods are finally delivered and accepted by **DEPED**. **DEPED** shall deduct the liquidated damages from any money due or which may become due to **THE JOINT VENTURE**, or collect from any of the securities or warranties posted by **THE JOINT VENTURE**, whichever is convenient to **DEPED**. Once the cumulative amount of liquidated damages reaches ten percent (10%) of the Contract Price, **DEPED** may rescind or terminate the Contract without prejudice to other courses of action and remedies available under the circumstances.
13. The **PARTIES** shall make every effort to resolve amicably and by mutual consultation any and all disputes or differences arising between the Parties in connection with the implementation of the Agreement. Should such dispute not be resolved amicably, it shall be submitted to arbitration in the Philippines according to the provisions of Presidential Decree No. 242 and Executive Order No. 292. Provided, however, that by mutual agreement, the Parties may agree in writing to resort to other alternative modes of dispute resolution.
