Item No.	Clarifications/Concerns	Response
1.	Requested to have a list of the establishment of Service Centers in the relevant areas of delivery or availability of Manufacturer's Nationwide On-site Support instead of a List of service centers nationwide by province or city to address the maintenance need of the equipment as stated in PBD.	
2.	Bidder asked if the TWG will conduct an inspection of the machines for mass production or will they be allowed to submit documents from their supplier abroad as proof that they are capable to do the manufacturing. She explained that most parts/ machines will be coming from abroad.	Refer to this SBB2. As part of the post-qualification evaluation, TWG must ensure that the supplier has the capability to produce the item. He explained that the list of equipment was based on locally manufactured goods. In case the manufacturer is from abroad, a list of equipment the bidder has, and a video showing the manufacturer's plant and equipment from abroad will suffice to prove their capability to manufacture the items.
3.	Clarified if bidders should provide proof of the brand name such as website or trademark	Brand offers must be specified in their proposal as stated in the PBD and must be traced either on the items or on the packaging. Proof such as but not limited to website and trademark must be provided for validation purposes and for tracing the source of the goods
4.	Bidder's License to sell for a chainsaw	Refer to this SBB2
5.	Clarified if the "TVL" word must be present in their contracts for SLCC or should deliverables such as refrigerators and freezers will suffice	It is not necessary so long as the track record shows that deliveries are TVL equipment or machines such as refrigerators, freezers, etc.
6.	Clarified if a partially paid contract can be considered as SLCC.	Completed contracts are those completely delivered, accepted, and paid, and the warranty period of which is over. A partially paid contract(s) will be considered an Ongoing Contract(s).
7.	Clarified the number of bidding documents set to be submitted if the bidders will be joining multiple lots and where to put the USB containing the accomplished excel file of Annex G.	Bidders may submit only one set of their bids (Original, Copy 1, and Copy 2) regardless of the number of lots they will be joining. USB should be placed inside Copy 1 Financial Envelope.
8.	Clarified the pre-delivery inspection process and the term spot the difference.	The basic rule for pre-delivery inspection is that the approved samples during post-qualification evaluation must be exactly the same as the item that will be delivered to

		the schools, thus, they will not proceed with the inspection and it will be considered as failed if there will be any discrepancies.
9.	Lot 4: Laptop Computer Requested to have an external SD and Micro SD card reader instead of a port for "1 x SD/Micro SD since latest laptops nowadays don't have built-in for SD/Micro SD.	Retained the original technical specifications.
10.	Lot 4: Laptop Computer Requested to have an original factory color for the casing instead of Casing and Mouse should be customized • Color Cyan Blue: C, M, Y, K (71,53,0,12) since these requirements really add cost and lead time for the principal manufacturers not to mention China are now in a lockdown state where most factories of the principal manufacturer are located	Retained the original technical specifications. Customized color is for safety/security purposes.
11.	Lot 4: Printer Requested to consider equivalent specifications for function and performance since different brands used different terminologies but have the same functionalities.	Terminologies must be in English, internationally accepted/adopted, and compliant with the technical specifications.
12.	Lot 4: Printer Requested to relax the requirement to 25 instead of Output tray A4 letter:50 since this will help open this to more bidders and brands for a competitive price.	Retained the original technical specifications.
13.	Lot 4: Smart TV Requested to have Component or Composite Video instead of Component and Composite video because nowadays Smart TV don't have both specifications component video are usually for old models of TV	Retained the original technical specifications.
14.	Requested to relax lead time from 120 to 180 calendar days upon receipt of NTP since manufacturer's Factories are mostly located in China were now had a lockdown due to COVID surge which greatly affects productions and logistics for all Manufacturers of IT components.	Retained the original delivery schedule.
